### 1. Declaration of End User

Where Swage Aero B.V. supplies goods onward to customers, Swage Aero B.V. acts as an independent commercial entity within the aerospace supply chain and ensures that such onward supply is conducted in compliance with applicable laws and regulations.

### 2. Intended End Use

The goods supplied to Swage Aero B.V. are intended for use in civil aviation, commercial aerospace, maintenance, repair and overhaul activities, training, tooling, inspection, and related industrial applications.

The goods are not intended for use in weapons systems, military combat operations, or other prohibited or restricted applications, unless explicitly authorized by the relevant authorities and agreed in writing.

### 3. Export Control and Sanctions Compliance

Swage Aero B.V. confirms that it complies with all applicable export control and sanctions regulations, including but not limited to European Union regulations, and where applicable, United States Export Administration Regulations and International Traffic in Arms Regulations.

Swage Aero B.V. will not knowingly export, re-export, transfer, or make available any goods in violation of applicable export control or sanctions laws.

### 4. End Destination

Unless otherwise stated in writing, the goods supplied to Swage Aero B.V. are intended for use within the European Union or other permitted destinations in accordance with applicable export control regulations.

Any re-export, transfer, or change of end destination shall be subject to compliance review and, where required, prior authorization from the competent authorities.

### 5. Non-Proliferation and Restricted Use

Swage Aero B.V. confirms that the goods will not be used, directly or indirectly, for the development, production, handling, operation, maintenance, storage, detection, identification, or dissemination of weapons of mass destruction, including nuclear, chemical, or biological weapons, or their delivery systems.

## **6. OEM Independence and Product Representation**

Swage Aero B.V. acknowledges that certain goods supplied within the aerospace tooling domain may be independently manufactured aftermarket products.

Swage Aero B.V. confirms that such goods will not be represented as original equipment manufacturer products, OEM-certified products, or OEM-approved products unless explicitly stated and contractually agreed.

Any reference to OEM names, trademarks, or part numbers is used solely for identification or cross-reference purposes.

## **7. Transfer and Re-Export**

Swage Aero B.V. shall not transfer, resell, or re-export the goods to any third party or destination subject to embargoes, sanctions, or other legal restrictions.

Where required, Swage Aero B.V. shall obtain appropriate end user statements, end use certifications, or export licenses from its customers prior to onward supply.

## **8. Record Keeping**

Swage Aero B.V. shall maintain records relating to the receipt, use, and onward supply of the goods in accordance with applicable legal and regulatory requirements.

Such records shall be made available to competent authorities upon lawful request.

## **9. Accuracy of Information**

Swage Aero B.V. confirms that the information provided in this End User Statement is true, complete, and accurate to the best of its knowledge.

Swage Aero B.V. acknowledges that any false or misleading statement may result in legal consequences, including penalties under applicable export control laws.

## **10. Governing Law**
